NNSG BOARD OF DIRECTORS MEETING MINUTES

- 1. Welcome and introductions / determination of quorum
 - Board Members: Gary Reese, Gerald Miller, Larry Hyslop, Dave Voth, Andi Porreca
 - Public: Doug Clarke, Madi Stout (via phone), Shauna and Nathan Morrill, Paul Mieman (UNCE)
 - President Gary Reese Called the meeting to order at 5:15
- 2. Public Comment/Short General Discussion Period, Adjust Agenda
 - Nathan Morrill's presentation to request funds for his Eagle Badge low sagebrush carcass caching project in Lamoille Canyon
 - i. An Eagle Scout Projects where he will be installing 25 sagebrush caches that are harvested in Pleasant Valley and installed at the Powerhouse area in Lamoille Canyon on November 2. Dave stated that NDA can donate the garbage bags needed for the project. Gerry made a motion to sponsor Nathan's project and donate \$250 which will go towards the purchase of biodegradable stakes and netting. Larry seconded and the motion passed.
